

## The WELS CEFStamp Program for Youth

The purpose of the WELS CEF Stamp Program is to involve WELS Youth in home and world mission work at an early age. This investment program serves as a great building block for our WELS children to learn clear, Biblical stewardship principles. This program also allows parents and teachers to instruct our WELS Youth to actively participate in WELS home and world mission projects going on throughout the world. This program can help WELS Lutheran elementary school teachers and Sunday School teachers as they teach WELS Youth about Christian stewardship principles.

## How does a WELS church or school participate in this investment program?

- 1) A church or school sends in the "Stamp Order Form" and sends it to WELS CEF, along with a check. This establishes a stamp purchasing account number. The "Stamp Order Form" can be found on the CEF website or you can call the CEF Office directly.
- 2) Upon receiving the "Stamp Order Form" WELS CEF sends the church or school the stamps, stampbook/applications and other support material requested. A stamp purchasing activity statement, along with another stamp order form, will be sent with each order to reflect the current balance due on the stamp account. A payment should be included with each subsequent stamp order to cover the amount of the stamps sent from WELS CEF. Stamps come in sheets of 30 for \$30/sheet.
- 3) The church or school will provide stampbook/applications to the students. The church or school will sell stamps to the students for \$1.00 to cover the purchase amount. Students can purchase stamps on a designated stamp day made by the church or school. When a stamp book is full, the teacher provides the student with a WELS CEF Offering Circular. The stampbook application is filled out by the student's parent (custodian) and returned with the full stamp book to the WELS CEF office.
- 4) WELS CEF then issues a One Year Savings Certificate in the child's name and sends it to their permanent home address. The parent is the custodian on these investment certificates so that statements and maturity notices can be handled accordingly.

<u>Please note:</u> No application is needed for additions to the stampbook accounts. Just complete the Additional Investment Form included with stampbooks. Also Note: A stampbook/application, individual investment application or additional investment form must accompany every stamp book sent to WELS CEF.

Through this program, a new investor is born who will hopefully support the mission work done through WELS CEF for many years to come.
